ABOUT STRGBA GSA

The Modesto Subbasin covers approximately 250,000 acres in Stanislaus County lying between the Tuolumne, Stanislaus, and San Joaquin Rivers. The seven agencies covering the Modesto Subbasin formed the Stanislaus and Tuolumne Rivers Groundwater Basin Association Groundwater Sustainability Agency (STRGBA GSA). STRGBA GSA has the authority and responsibility to manage the groundwater basin and submitted Modesto Subbasin's Groundwater Sustainability Plan (GSP) to the Department of Water Resources (DWR) on January 31, 2022. A revised GSP was submitted to DWR on July 12, 2024.

ABOUT THE WELL MITIGATION PLAN & MANAGEMENT ACTIONS

Modesto Subbasin's Well Mitigation Plan (WMP) and Management Actions (MA) are an essential piece of the GSP submitted to DWR. The WMP and MA must be developed by January 2026 and the MA must be implemented in 2027.

STRGBA GSA is seeking to form a new, small workgroup to provide guidance and input in developing and implementing a Well Mitigation Plan (WMP) and Management Actions (MA) for the Modesto Subbasin. We encourage representation from throughout the subbasin and ideally, would like to solicit and select participants from each management area.

Simultaneously, STRGBA GSA has issued a request for proposals for a consultant to lead efforts on developing and drafting the WMP and MAs. There is also an ad hoc committee consisting of OID, MID and Stanislaus County staff that will help facilitate this effort and direct the workgroup.
