Dear Miguel Alvarez:

This letter acknowledges that the California Department of Water Resources (DWR) has received your October 26, 2022, email that references your previous June 21, 2021 emailed request to transfer the responsibility to use, manage, and maintain the 17 monitoring wells constructed using funding from Grant Agreement # 46-12653 to the Stanislaus & Tuolumne Rivers Groundwater Basin Association Groundwater Sustainability Agency (STRGBA GSA).

This letter serves as notification that DWR concurs with your request to transfer responsibility for these wells to STRGBA GSA provided that STRGBA GSA agrees to uphold all terms of the grant agreement for post-construction requirements to maintain and operate the wells for the 15 years useful project life of these wells.

Please be mindful that the Grantee is still obligated to continue records retention for the monitoring wells construction as there is a potential for a post completion audit of the Grant.
