5. Public Outreach Update

Enas mentioned that MID staff will be putting together a newsletter introducing the GSA and describing our recent activities. The newsletter is scheduled to be released by early March and member agencies should submit stakeholder names for mailing list.

Stanin discussed the Implementation Service Plan developed by Craig Moyle from Stantec as required by the Facilitation Support Services contract with DWR. As part of the plan, Moyle would like to arrange interviews with stakeholders from within each GSA agency's jurisdiction and develop a list of key areas of interest from the stakeholders.

6. GSP Update

Stanin stated that revised draft Section 1, Administration Information and Section 2, Plan Area, of the GSP are complete. The draft sections will be uploaded to the STRGBA GSA website for public review. Stanin also mentioned that the modeling team is developing boundary conditions for the Tuolumne River to input into the model. She suggested setting up a meeting with the Turlock Subbasin GSA's to come to an agreement on how the model simulates the groundwater/surface water interaction. The group directed Stanin to follow up with the West and East Turlock GSA's about meeting sometime in March.
